### **Fuel Bids**

District 1 Commissioner Larry Berry made the motion to accept the bid from MFA Oil Company for diesel fuel for Road District #1 at a cost of \$2.76 per gallon. District 2 Commissioner Scott Harms seconded the motion. The motion passed by vote: Larry Berry (Yes), Scott Harms (Yes), and Steve Daleske (Yes). Other bids were received from Zollicker Oil Company at a cost of \$3.015 per gallon and from Warsaw Oil Company at a cost of \$3.02 per gallon; the County accepted the low bid price.

District 1 Commissioner Larry Berry made the motion to accept the bid for unleaded gasoline for Road District #1 from MFA Oil Company at a cost of \$2.265 per gallon; District 2 Commissioner Scott Harms seconded the motion. The motion passed by vote: Larry Berry (Yes), Scott Harms (Yes), Steve Daleske (Yes). Other bids were received from Warsaw Oil Company at a cost of \$2.475 per gallon, and from Zollicker Oil Company at a cost of \$2.485 per gallon. The County accepted the low bid price.
